## Human rights and democracy

Proper standards for human rights and democracy are of great importance for the establishment of a democratic state. The activities within this area constitute a vital part of the Swedish programme for Bosnia and Herzegovina, and are expected to remain an important priority in the foreseeable future.

Sida has channelled grants through Swedish and international organisations to further democracy and strengthen human rights in Bosnia and Herzegovina (BiH) since 1994. Civil society in BiH has received extensive support. The support has been very varied and covered many have included and continue to include the development of independent media, programs in support of women and gender equality, youth projects and democracy training. The Swedish Helsinki Committee, Olof Palme International Centre and Kvinna till Kvinna support local initiatives to further democracy.

- Core support to the Media Task
   Force of the Stability Pact (based in Amsterdam) for the task of coordinating efforts in the field of media as well as assisting the implementation of the newly-adopted Media Code.
- Support to the Transitions On-Line, Balkan Reconstruction Report regional programme, similar to the IWPR programme with journalist training and background reporting.
- The Media Development Loan Fund provides credits to media enterprises in the region. Their Media Training Centre offers training which includes media

- management and leadership.
- Support to the Ombudsman Institution in the Federation of BiH regarding the running costs of the Field Office in Velika Kladuša.
- Support to the International Commission on Missing Persons for their work with identifying exhumed bodies using DNA analysis.
- The work with Proni Institute for Social Education regarding youth leadership training was temporarily put on hold during autumn 2003 pending a restructuring of the organisation.
- Support to the Balkan Children and Youth Foundation for their work with local youth organisations, including identifying best practices in youth work.

## **Future plans**

The growth and development of civil society is crucial to the future development of Bosnia and Herzegovina. Sweden will continue to support local media, however mainly in the form of credits instead of direct support. Sweden will expand its present credit facilities. Measures to combat trafficking in human beings will continue to have a high priority, albeit increasingly concentrating on prevention and information. Projects aiming at preventing child abuse, violence in the home and promoting participation of children and young people in the life of the community will be given prior-
