Gender equality is a key element of the human rights system established by the Universal Declaration of Human Rights in 1948.

The Convention on the Elimination of All Forms of Discrimination against Women, CEDAW, defines what constitutes discrimination against women and sets an agenda for national action to end such discrimination. CEDAW was adopted in 1979.

The **United Nations Fourth World Conference on Women**, in Beijing 1995, resulted in a Platform for Action, which states:

"Equality between women and men is a matter of human rights and a condition for social justice and is also a necessary and fundamental prerequisite for equality, development and peace."

Gender and sex

Gender is an overarching and fundamental variable. Gender systems are rooted in a place, time and culture and determine what is expected, allowed and valued in a woman/man and girl/boy in these specific contexts. Sex traditionally refers to the physiological and hormonal markers which are used to define humans as either female or male.

Current academic discussions of gender note that the relationship between 'sex' and 'gender' is not entirely straightforward. 'Sex' is viewed today by many as a cultural concept. Power and sex/gender are interconnected – that the dominant role in a relationship is often understood to be more 'masculine' shows this connection clearly.

Empowerment of women

Empowerment of women relates to the process of women gaining power and control over their own lives. It involves expansion of choices, and increased access to and control over resources, information and actions.

The basic right of all individuals to decide freely and responsibly the number, spacing and timing of their children. And the right to have access to sexual and reproductive health care services: to seek, receive and impart information in relation to sexuality; to receive sexuality education: maintain bodily integrity; choose one's partner; decide to whether to be sexually active or not; and to have consensual sexual relations.

EQUALITY AND DEMOCRATIC DEVELOPMENT Gender equality is crucial for achieving sustainable democratic development. Sida should therefore promote equal rights to, and participation in, political, economic, religious and social life and decision-making for women and men, girls and boys. Sida should actively combat gender discrimination.

EQUALITY AND POWER STRUCTURES Power structures are fundamental for working towards equality between women and men, girls and boys. Sida should therefore take into account and act upon

unequal power relations between and among women and men.

EQUALITY AND GENDER RELATIONS Gender equality is about the relationship between women and men, girls and boys. Development is about creating and supporting processes through which human beings are able to realise their full potential. Gender stereotypes often

block this process, for men as much as for women. Differences between societies should be taken into consideration in Sida's work, although Sida should always base its efforts on the universal declaration of human rights. **EQUAL ECONOMIC OPPORTUNITY** Equal opportunity for all is fundamental to achieving sustainable and democratic development and pro-poor growth. Sida should always contribute to removing

constraints on the full participation of women and girls in the economy, regardless of whether these constraints are based on social norms, religious values or
